Regular Meeting Minutes for Wednesday, February 3, 2021

A Regular Session of the Piedmont Park Commission was held February 3, 2021, via teleconference, consistent with Executive Orders N-25-20 and N-29-20 and the Alameda County Health Official's Order #20-04. In accordance with Government Code Section 54957(b), the agenda for this meeting was posted for public inspection on January 29, 2021.

Minutes	Approval of Minutes for Park Commission meetings of 11/04/2020 and 01/06/2021
	Resolved, that the Park Commission approves the Park Commission meeting minutes of November 4, 2020 and January 6, 2021 as presented. Moved by Brumfiel, Seconded by Horner Ayes: Brumfiel, Dunlap, Goodman, Horner, Mahany, Ruby Noes: Absent: Wu
	Chairperson Dunlap welcomed Councilmember Andersen as the Council Liaison to the Park Commission and new Public Works Director Gonzales.
Parks & Open Spaces Sustainable Practices	Sustainability Program Manager Alyssa Dykman indicated she looks forward to implementing the Climate Action Plan and Green Infrastructure Plan, ensuring sustainability practices are an integral component of parks and open spaces, and engaging residents to raise ecological awareness. She indicated she has been working with Piedmont Evergreen to provide outreach and technical assistance to residents. She related her confidence that the City can bring sustainability to open spaces and parks in partnership with the community.
	Parks and Project Manager Nancy Kent stated Ms. Dykman will help the City move toward more sustainable practices.
	There was no Public Testimony on this matter.
2021 Heritage Tree Nominations	Ms. Kent announced that nominations for Heritage Tree designation are open, with a deadline of March 19, 2021. She noted that the 2021 winner would be announced at the April 7, 2021 Park Commission meeting, along with the 2020 winners, which were not announced last year due to the COVID-19 pandemic.

	Commissioners Brumfiel and Horner volunteered to submit articles about prior winners to <i>The Piedmont Post</i> and <i>The Exedra</i> .
	Commissioner Horner suggested the City provide a map of tree locations.
	There was no Public Testimony on this matter.
2021 Virtual Arbor Day Celebration	Chairperson Dunlap requested the Park Commission identify a date for the celebration and assistance needed from staff. She announced Zack Parisa, Piedmont resident and forester, has agreed to be the speaker for the Arbor Day celebration. Chair Dunlap proposed taping the celebration in advance of the date, including the PHS jazz band's music and a children's event, and incorporating Heritage Tree winners into the event.
	Ms. Kent advised that KCOM has agreed to prepare a video of Heritage Tree winners, and the Recreation Department has agreed to assist with a children's event. She outlined a children's program involving street trees.
	Commissioners and staff discussed whether or not to combine the Arbor Day and Earth Day celebrations as well as the details and publicity for the events.
	There was no Public Testimony on the matter.
Park Funding Opportunities through Proposition 68 Grants	Ms. Kent reported that the City will apply for a Proposition 68 grant to fund Phase 1 of the Linda Beach Conceptual Master Plan. She noted community engagement for the master plan was robust and well done, and grant criteria for the project design includes consideration of the surrounding neighborhood and residents' concerns and needs. She added that the application is due in March, funds will be awarded in late summer, and the grant does not require matching funds.
	There was no Public Testimony on this matter.
	Commissioners appreciated and supported Ms. Kent's efforts to obtain funding for this project.
Highland-Guilford Steps, Handrail & Lighting Project	Ms. Kent indicated that the City engineer is preparing a cost estimate for the Highland-Guilford Step, Handrail, & Lighting Project that the City will share with the Piedmont Beautification Foundation's (PBF) She related that PBF will utilize the estimate in evaluating its donation to the City.
	There was no Public Testimony on this matter.
Piedmont Garden Club Donation	Ms. Kent announced that the Piedmont Garden Club's annual donation for 2020 would be utilized to replace and revitalize the plantings in and around the Fire Department. She indicated that shrubs would be replaced using drought-tolerant and native plantings and the irrigation system would be upgraded.
	There was no Public Testimony on this matter.
COVID-19 Impacts on Parks Update	Ms. Kent stated there has been no change with respect to COVID-19 impacts since the previous update. She noted annual field maintenance is underway with modifications to shorten the usual timeframe and to close only the natural turf areas.

There was no Public Testimony on this matter.

Monthly Maintenance Report – January Public Works Supervisor Nick Millosovich reported that staff has completed maintenance of 24 pedestrian pathways, installed violas, removed a downed tree and limbs resulting from recent storms, cleared storm drains, and pruned trees. He noted the annual street tree pruning contract will begin February 16, 2021. He added that sandbags are available for pickup by residents at the Corporation Yard.

There was no Public Testimony on this matter.

Commissioner Brumfiel relayed compliments posted to Facebook regarding staff's quick cleanup of storm debris.

RECOMMENDATION

This is an informational item. No action is required.

BACKGROUND

EBMUD is proactively replacing its pipelines to improve water service, reduce water loss and the number of pipeline breaks in the service area which includes the City of Piedmont. In the East Bay, 4,200 miles of pipelines, under bustling neighborhoods and busy streets, deliver high-quality water to 1.4 million customers.

Half of these pipelines were installed more than 50 years ago. The pipelines are constructed of cast iron, asbestos cement, steel, or plastic. There are many factors including soil conditions, proximity to active faults, system operating conditions, and construction materials that determine how long a pipeline will last. EBMUD regularly reviews its processes and materials to replace pipelines for efficiency, effectiveness, and resilience.

EBMUD is proposing a project on Manor Drive to replace some of their aging infrastructure. The project is proposed for Manor Drive from Arroyo Avenue to Cambridge Way. The project involves abandoning the existing 6-inch cast iron water pipe and installing a new 6-inch PVC water main. In addition to the water main, EBMUD will be reconnecting 36 water services to the new water main. The work will be done under and Excavation Permit that the City will issue to EBMUD. Part of the conditions of the excavation permit will be for repaving portions of Manor Drive. Although staff has not finalized the conditions, it is anticipated that EBMUD will be responsible for repaving at least half of the street. The City is working with EBMUD to potentially have the City pay for paving the portion of the street that EBMUD's project won't cover (to provide new pavement for the full width of the street.)

Based on site visits of the project, several sections of curb and gutter, drainage structures as well as some sidewalks should be replaced prior to paving of the street. All curb and gutter replacements should take place prior to paving. Replacement of sections of the curb, gutter and sidewalk is the City's responsibility. If the City and EBMUD can come to an agreement on which agency will do the paving and what the cost sharing will be, EBMUD would like to move forward with their project this summer.

DISCUSSION

At the January 6, 2021 Park Commission meeting, the first report on this proposed project was presented. In anticipation of the repaying project, the City has completed an engineering review of the existing curb and gutter, sidewalk and drainage issues on the street. The proposed infrastructure improvements is attached as EXHIBIT A.

In order to protect and address potential impacts on Manor's street trees, staff has also consulted with HortScience/ Bartlett Consulting arborist, Darya Barar. Ms. Barar has completed <u>A Tree Assessment Plan</u> which includes a plan of the two block project and an assessment of the tree conditions and suitability for preservation. A total of 51 street trees were tagged and evaluated. Manor Drive street trees consist of the following species:

- (30) Sweetgums: (Liquidambar styraciflua),
- (16) Chinese pistache (Pistachia chinensis),
- (4) Little leaf Linden (*Tilia cordata*)
- (1) Redwood(*Sequoia sempervirens*)

The arborist report is attached and has been posted on the City's website: <u>https://go.usa.gov/xs8mA</u> EXHIBIT B.

On February 5, 2021 Daniel Gonzales, Director of Public Works, Nancy Kent, Parks and Project Manager, Steven Van Saun, Coastland Civil Engineer and Darya Barar, Consulting Urban Forester and Arborist, met to discuss how curb and gutter replacement on Manor Drive would impact trees in the right of way. The goal was to identify two situations: 1) where trees had displaced or pillowed over the curb and 2) where street grades and displacement were so severe that the proposed curb work would result in severe damage to the adjacent tree. The combination of damage and limiting replacement factors will require tree removal in the following five locations:

- Tree #20 Sweetgum- located in front of 18 Manor Dr.
- Tree #216 Sweetgum- located in front of 21 Manor Dr.
- Tree #223 Sweetgum- located in front of 69 Manor Dr.
- Tree #200 Sweetgum- located in front of 100 Manor Dr.
- Tree #198 Sweetgum- located in front of 100 Manor Dr.

Ms. Barar also determined that root pruning will likely be required in an additional 17 locations. In these cases, the City's policy on curb and gutter, driveway, and sidewalk replacement will be enacted and efforts will be made to preserve the tree. Similar to the revised approach the City took during the repaving of Magnolia Ave., the City will continue to work with the City engineer and consulting arborist in regards to the preservation of street trees during infrastructure and paving projects, The City Arborist and HortScience /Bartlett Consulting will consult with the City Inspector during the construction process to ensure the existing street trees are protected and preserved. A summary of the arborist's determination on February 5, 2021 is attached as EXHIBIT C.

As the project planning progresses, City staff will update the Park Commission on the project schedule. Staff will also update the Commission at a future meeting on street tree replacement options. Replacement street tree planting will occur as soon as the repaying work is completed.







Dear Ms. Kent:

On February 5, 2021 you (Nancy Kent, Landscape Architect); Daniel Gonzalez, Director of Public Works; Steven Van Saun, Coastland Civil Engineer and I met to discuss how curb and gutter replacement on Manor Drive would impact trees in the right of way. Our goal was to identify two situations: 1) where trees had displaced or pillowed over the curb and 2) where street grades and displacement were so severe that the proposed curb work would result in severe damage to the adjacent tree.

We found a combination of damage and limiting replacement factors in the following five locations:

- 1. Tree #207 located in front of 18 Manor Dr.
- 2. Tree #216 located in front of 21 Manor Dr.
- 3. Tree #223 located in front of 69 Manor Dr.
- 4. Tree #200 located in front of 100 Manor Dr.
- 5. Tree #198 located in front of 100 Manor Dr.

Root pruning will likely be required in an additional 17 locations. In these cases, the City's policy on curb and gutter, driveway, and sidewalk replacement will be enacted. The City will make every effort to preserve the tree. The City Arborist will determine in the field if root pruning required to complete the project will destabilize the tree and therefore warrant tree removal. If the tree is preserved, the City is committed to more frequent inspection after construction is complete.

The City hired consulting arborists HortScience/Barlett Consulting to prepare a report on 51street trees, (30) Sweetgum (*Liquidambar styraciflua*), (16) Chinese pistache (*Pistachia chinensis*), (4) Little leaf Linden (*Tilia cordata*) and (1) Coast Redwood (*Sequoia sempervirens*) for the two block section of Manor Drive. The report provides an inventory of the trees, conditions and suitability for preservation. The arborist report will be available on the City's website : https://go.usa.gov/xs8mA

The East Bay Municipal Utility District (EBMUD) has identified, as part of its pipeline replacement program, a project to replace and install a new water main for Manor Drive between Arroyo Ave. and Cambridge Way. Although EBMUD's construction schedule has not been finalized, City staff and Coastland Engineers have been coordinating with the utility. The water main replacement will require that the two block section of Manor Drive be repaved.

In anticipation of the pipeline replacement and repaving project, the City has begun an engineering review of the existing curb and gutter, sidewalk conditions and drainage issues on the street.

On January 6, 2021, the Park Commission received an update on the EBMUD Pipeline project on Manor Ave. The City Engineer and arborists have reviewed the engineering work that is required to install the new curb and gutter, and replacement sidewalks and have designated the street trees that will need to be removed in order for these engineering improvements to be installed. Of the 51 street trees evaluated, the following 5 trees need to be removed in order for the engineering improvements to be installed:

- Tree #207 located in front of 18 Manor Dr.
- Tree #216 located in front of 21 Manor Dr.
- Tree #223 located in front of 69 Manor Dr.
- Tree #200 located in front of 100 Manor Dr.
- Tree #198 located in front of 100 Manor Dr.
