## **Experience Related to this Appointment**

For more than 20 years I have overseen large public budgets and complex organizational challenges that have required innovative approaches to achieving financial and operational efficiencies. At UC Merced, I oversaw the Merced 2020 project, a one-million-square-foot capital project that, due to the lack of State capital funding, required a public-private partnership that represented not the first of its kind in the University of California, but a first for U.S. public higher education.

#### Why are you seeking this appointment?

My experience fits and, after 20 years in Piedmont, I have the time and opportunity to give back. My previous two years experience on the Budget Advisory and Financial Planning Committee and the Civil Service Committee have given me a new and important perspective about the challenges facing Piedmont. Finally, I live in a small pocket of Piedmont that is mostly young families and retirees living in small bungalows; we moved here for the school system and the community, but it has required a financial sacrifice.
