I have dedicated my professional life to running youth enrichment programs. I've worked in arts and recreational camp programming for the past 20 years, including roles as the Camp and Family Programs Manager at the JCCSF and Founding Education Director of Bay Area Children's Theatre (BACT) where I created programming for over 3,000 students annually in after school and camp programs throughout the Bay Area. I expanded the programming at BACT from 2 classes in Piedmont to over 30 classes per week in 6 different cities, and had very close working partnerships with the large recreation departments of Pleasanton and San Ramon, with contracts totalling over \$150K year year.
