RECOMMENDATION

Approve the attached resolution accepting the official certificate of election results prepared by the Alameda County Registrar of Voters and declaring the results of the General Municipal Election held November 8, 2022.

BACKGROUND

City Charter Article VIII requires that city elections, whether general or special, be conducted in accordance with the provisions of the Elections Code of the State of California. The Elections Code states that the governing body of the city shall meet and declare the results of the election upon completion of the canvass and that they shall pass a resolution reciting the fact of the election. The attached resolution has been prepared in compliance with this code.

The canvass of votes as provided by the Registrar of Voters includes precinct by precinct results for Piedmont. With that said, the Registrar consolidated Piedmont's six usual precincts into two for this election.
